FGC DirectSupport is a convenient way of giving to Friends General Conference through a monthly electronic fund transfer from your bank account to FGC's. It is the easiest way to provide year-round support that helps nurture a vital Religious Society of Friends.

Advantages of *FGC DirectSupport*:

- Helps to keep FGC strong all year—supported by your regular monthly contributions.
- Allows you to automatically spread your contribution throughout the year.
- Eliminates regular solicitations. ***FGC DirectSupporters*** will receive no periodic solicitations (except for special appeals).
- Reduces paperwork for our staff and saves you the trouble of writing checks.
- ***FGC DirectSupporters*** receive a summary acknowledgement/tax receipt at the end of each calendar year.

DETAILED TERMS:

- The authorization to charge your account is the same as if you personally signed a check to Friends General Conference.
- You may increase the amount of your monthly contribution at any time by sending a written statement to FGC.
- A record of your *FGC DirectSupport* transfer appears on your monthly bank statement. This record serves as your receipt. You will receive an annual acknowledgement of the total amount given each year.
- You have the right to authorize your bank to reverse any *FGC DirectSupport* gift. This must be done by written notice to your bank within 15 days after the date of your bank statement or within a period of 45 days after the transfer was debited to your account.
- You may terminate your participation in *FGC DirectSupport* at any time upon written notice to FGC.
- All changes—terminations, changes in debit amounts, or bank account changes—must be received by the first of the month in order to affect that month's transfer.
- At this time we are unable to offer the *FGC DirectSupport* through Canadian or other non-U.S. banks.
